**MAHA PREIT (Mahatma Phule Renewable Energy and Infrastructure Technology limited** , a subsidiary of MPBCDC, a Govt of Maharashtra Undertaking) invites applications for following post on 3 years contract period. Any eligible officer working in respective Govt of Maharashtra (GoM) department or PSU may also apply for deputation through proper channel.

(1) Eligibility :

Sr. No	Post	Qualification , Eligibility, and Job Profile
(1)	Dir (Projects)	Graduation in any branch , with minimum 15 years' Experience in Public Administration in GOM and must have worked in Housing department, GOM /MHADA/ MMRDA/CIDCO/SRA / MCGM etc or superannuated from Govt of India from dept. of Housing / Urban Affairs/ HUDCO having worked minimum 10 years in the rank of Executive Director or equivalent and above , dealing with Affordable Housing , Housing for PAP , Low cost housing , Exposure of housing or National mission on housing addressing climate change concerns , Housing projects by International Funding agencies (IFA)/ world bank aided projects , Housing projects for weaker sections. Must have worked at least 5 years in the rank of JS and above at GoM and equivalent at GOI. Applicants superannuated from I.A.S.( MH cadre) having otherwise eligibility will be preferred. The job profile may also additionally include supervision of any Projects implemented by Project Directors under MAHAPREIT as decided by management of MAHAPREIT.
(2)	Protocol Officer (PO)	Minimum 10 years of experience in Govt of Maharashtra Company / Maharashtra State PSU as Protocol officer or Protocol Assistant .The grade and rank will be decided as per credentials of selected candidate .

(2) Applicable For ALL Post ( if not specified ):-

- (a) AGE : (i) For Dir (Project post) – For Applicants superannuated from Govt of India or IAS (Maharashtra cadre ) max Age 62 years on the date of application and (ii) Age for Sr No 2 - For applicants superannuated from Govt of Maharashtra max age is 60 years on the date of application. (iii) For applicants desiring to join on deputation, No age is prescribed however minimum 15 years' experience is required in the respective department of GOI or GOM of its agency with eligibilities as mentioned for respective post. (iv) The age will be relaxed maximum 2 years if necessary for such candidates if otherwise eligible for any post.
- (b) No dept. inquiry or proceedings shall be in process, on the date of application.
- (3) Salaries, perks and Allowances: Generally , the Salaries/ honorarium for the post of Director (Projects) and Protocol Officer will carry Salaries/ honorarium to that of respective post or equivalent in State PSU. The salaries and /or honorarium of selected candidates will be negotiated as per experience and rank of candidate selected, considering last pay at the time of superannuation, with applicability of rule of Pay minus pension for superannuated candidates. Perks and Allowances will be as per policy of MAHAPREIT as amended from time to time. If any candidate opts for deputation, his /her pay will be matched to his/her current pay in parent organization. Terms of Appointment: As per Annex 1.
- (4) Tenure: 3 years, may be extended for 2 years if required.
- (5) Applicability of GOM service rules /regulations and conduct and disciplinary rules : ALL service rules , regulations, polices as amended from time to time by GOM, Conduct and Disciplinary rules shall be applicable prevailing as on date during complete tenure of contract period.
